4/180321 Public comments on matters on the Agenda, and reports from District and County Councillors

In response to a question it was noted that a new supplier might need to be found for batteries for the speed sign; the supplier in Germany has difficulty exporting equipment because of post-Brexit arrangements. The desirability of a Neighbourhood Plan for the village was discussed and it was agreed this would be considered at a future meeting.

Cllr Field had sent a written report. Cllrs Whitehead and Passmore reported on the District's 2021/22 budget. Council tax would increase by 1.66%; the government has covered most Covid-related costs. A sum has been set aside for Covid recovery projects. Domestic abuse cases have increased in number during the pandemic, as have cases of online fraud. There have been 18 cases of dog thefts in the past year; owners are advised to be careful and to be sure their pets are microchipped.

Cllr Whitehead has discussed the dog training planning application in Barham with the planning officer; the planners and also the Forestry Commission are looking at the situation.

Some guidance for individuals will be published on the website. There was a discussion about whether The Hut could be more carbon-neutral, and the matter will be discussed by The Hut Committee.

A budget proposal for 2022/23 and onwards would be discussed at future meetings.

It was noted that CIL funds amounting to £1,264.69 need to be committed for spending on a specific project during 2021.

Concern was expressed about the speed of vehicles travelling on Main Rad towards the bridge and in both directions on the B1078 at the same junction. It was agreed the question of reducing speed limits should be raised.
